Easter Seals Camp Challenge is a place where dreams come true. Day Break at Winter Park is an Adult Day Services program that offers senior citizens with special needs and their families an alternative to daytime home care or nursing home placement. Day Break is licensed by the State of Florida Agency of Health Care Administration.
